The Village of Lena is a municipality incorporated and organized under the laws of the State of Illinois for the purpose of providing its residents with the following services:

Police Protection;  
 Sewer and Water Services; Cemetery Services  
 Electrical, Gas, Telephone, and Cable Franchise Services; and  
 Street and Public Transportation Services.

The Village of Lena has certain functional subdivisions which are listed in Table I. The approximate amount of operating budget of the Village is \$2,329,400.00. The Village's primary office, the Village Hall, is located at 122 East Main Street, while secondary facilities are located at 201 Vernon Street, 222 East Townline Road, and 230 East Townline Road.
